MI-PI-08-ARH/2014 - Call for interest for 1 Post-Doctoral Research Assistant Positions (M / F)

Biomaterials for Regenerative Medicine

The University of Aveiro (<http://www.ua.pt/>) intends to promote the development of the research area of biomaterials for regenerative medicine, and invites applications for one 12-month positions in Cell Biology, In the área of Evaluation of biomaterial-host interaction in animal models.

The position is equivalent to Assistant Researcher (index 195), working full-time, ca. 3,192 euros/month, gross salary. The candidates must have a doctoral degree (obtained at ten or more years ago) and relevant post-doctoral research experience in the mentioned area including european accreditation to work with laboratory animals. Applicants should have a good track record of publication in SCI journals (more than 30 published papers), experience in (co)supervising at graduate and post-graduate levels, strong communication skills and the ability to pursue an independent research career. They will be encouraged to collaborate with other relevant UA researchers within their fields. Outstanding experience and scientific productivity measured through citations and the impact factor of journals of published papers will be the main evaluation vector. If deemed necessary, the candidate will be called in for an interview.

Applications should be addressed to the Rector of the University of Aveiro and remitted by March 03 2014 with the subject "MI-PI-08-ARH/2014 - UAVR Regenerative Medicine Assistant Researcher" by email to sgrhf-concursos@ua.pt, identifying the subject of the call and subarea.

Applications must include a Cover Letter describing the candidate's motivation for the position, a detailed CV, with reference to ISI publications, dated and signed, contact information, two recommendation letters, copy of certificates of academic and professional qualifications, and of an identification document (passport/identity card or equivalent). All documents must be in PDF format, in order to be accepted. Failure to comply with the deadline for submission, as well as the lack of or late submission of the documents mentioned above determines the exclusion of the selection process. Candidates who do not meet the conditions mentioned within this call will not be considered for selection.

The academic and professional profile(s) of candidate(s) will be considered on an individual basis regarding their suitability to the requirements of the position, maintaining this institution the freedom to contract, reserving however the right not to do so regardless of the results achieved in this call.

This call for interest does not render the right to any contract resulting from the relative comparison of the curricula presented. It envisages only a future invitation to potential candidates in accordance with Article 14 of Decree-Law No. 125/99, of 20/Apr, taking in consideration the relevance of curricula and the opportunity and needs at the University of Aveiro.
